Please understand and appreciate that this is my personal comments as a City of Benicia Resident and in no way related to the Chamber of Commerce.

I am writing to you regarding the Two-Step request by Mayor Young and Vice-Mayor Campbell regarding the City of Benicia taking a stance on the potential recall of 2 Benicia School Board Trustees.

Council Members,

l am writing to you regarding Agenda item 14.D - "Two-Step Request to Consider Whether the City Council Should Take Position on Proposed Benicia School Board Recall Effort."

I am asking the City Council NOT take a stand on Benicia School District recall efforts by citizens of Benicia because:

- A) The City Council has no purview over,
- B) this is being done by private citizens, and
- C) is legally allowed.

Regarding Steve Young's numerous posts on cost, there is no cost for a recall unless there is 20% of registered voter signatures collected. If that occurs, that would represent the 'will' of the citizens that do not see those 2 board members fit for their public office position. In that case, the \$205-\$300k is an end result of those board members not stepping down even AFTER the 'will' of the people have spoke.

Mayor Young has stated publicly, more than once, that he has NO interest to involve, nor chooses to involve the city when it comes to decisions with regards to our schools. This "Two-Step" request by Mayor Young and Council Member Campbell appears to be nothing more than a political move. In addition, this request also contradicts a statement made by Mayor Young just recently stating "...I do not believe it is proper for the City to try and influence the operations of the School District to lobby the City Council as it did in 2017 when we were debating cannabis regulations..."

In an email exchange with myself and Mayor Young on February 8, 2021, Mayor Young stated "You are correct that I have taken a personal position in opposition to the recall." and "I am sure everyone believes they are doing what is best for our children, regardless of where they stand on the recall issue. But it is up to the school board to deal with the issue." and "you are correct that I do not understand what is driving the recall." This email exchange alone proves to me that Mayor Young is wanting to force a position on this recall strictly for political gain. The fact that he does not understand exactly why there even IS a recall confirms the City needs to remain out of this matter. Aside from this, School Board members are elected to represent our schools, our teachers, and our students. They are NOT elected to intervene with City matters. Just as our City Council is NOT elected to intervene with our School matters.

I am asking that the council refrain from getting involved with the recall of school board members, Zada and Maselli. Us parents are the ones who have a vested interest when it comes to the education our children receive, and who we elect to represent our schools and children. With that being said, Mayor Young and Councilman Campbell have no children attending BUSD schools. Again, clearly a political move, and not one they would have a personal vested interest in. The conflict of interest has many of us scratching our heads asking "Why"?


And if the council chooses to get involved, I and many other parents will be questioning the motives and may be filing more than just a recall on the board members.

Good evening -

Municipal officers not infrequently assume a degree of control over the public schools which they do not legally possess. Such an assumption of power may grow out of failure to distinguish clearly between the functions of the municipality and those of the school district, or it may represent a deliberate attempt to subordinate the schools to the control of the mayor and the city council. In either case the results are likely disastrous. Subordination of the school board to the mayor and the city council may result in unwise and ill-considered educational policies. It is therefore a matter of great practical importance, that the school board members and supers of our city schools know the extent of their own powers as well as the limitations of the powers of the city authority.

There are, therefore, well defined legal principles governing the relationship.

In legal theory the public school is a state, not a local or municipal institution. Power to maintain a system of public schools is the attribute of government in much the same sense as is the police in our town. Please keep the city and schools separate to make an informative decision. Should those members of the school district not have the ability, knowledge or have the best interest of the town in mind, then they should step down and allow those who can.
